I am writing to you on behalf of Save Stepps Greenbelt Committee.

The revised application 20/01359/MSC hangs in the balance. Having reviewed the application documents, I am of the opinion that it does not achieve the high design expectations of North Lanarkshire Council nor of Reporter Cook in her appeal statement PPA-320-2137 and more importantly the community of Stepps.

I urge you to review the aforementioned planning application recently submitted by Barratt and Cala. The application must demonstrate that the landscape and visual impacts of the development have been mitigated and that Policy DSP4, Quality of Development, which supports development only where high standards of site planning and sustainable design are achieved.

Below is a summary of what I believe the applicants are saying:

They claim that the development footprint of 200 housing units has been reduced.

Comment: The housing units have been reduced by one unit only from 200 to 199.

They claim that the reduction of one unit will allow more extensive landscaped edges, retention and reinforcement of the existing landscape features with the aim of doubling the landscape buffer along the western boundary and significant enlargement of the landscape buffer to the northern boundary.

M Comment: Only a significant reduction in the housing units would achieve all of this and result in wider greenbelt boundaries

T They claim that the visual impact of 199 houses on the landscape fabric of the site is *Not Significant* and the magnitude of change is assessed to be *Low* and the proposed development

is in keeping with the character of the surrounding area and will provide a *Positive Addition* to the settlement of Stepps.

C Comment: The density of the houses will create an urbanised setting which will not integrate well with the semi-rural character of Stepps. The photomontages show that this development will be highly visible from all viewpoints around this prominent site and that it will take 15 years or more for new tree planting to reach maturity to mitigate its visual impact.

This application will come before the planning committee in due course. I seek your continued support in this matter to ensure that a development of the highest quality is achieved for Stepps.
